

TIO MARKETS PRIVACY POLICY

1. INTRODUCTION

1.1 TIO Markets Ltd. (the “TIO Markets” or “Company”) is an International Business Company (the “IBC”) incorporated in Saint Vincent and the Grenadines holding a Certificate of Incorporation with Number 24986 IBC 2018.

2. PRIVACY POLICY

2.1 Protecting the privacy and safeguarding the personal and financial information of TIO Markets clients and website visitors is one of our highest priorities. The following Privacy Statement explains how we collect and protect your information.

3. COLLECTION OF PERSONAL INFORMATION

3.1 We collect information required to open an account, to transact business effectively and to safeguard your assets and your privacy. To do this, we gather information to help us assess your needs and preferences. The information we collect directly from you includes information required to communicate with you, including your name, mailing address, telephone number, e-mail address. We also collect birth date and your location information.

4. USAGE OF PERSONAL INFORMATION
